Is the Transatlantic Relation Back from the Dead, and for What?

The crisis in Ukraine could herald a new era for closer Europe-US cooperation on defense and security, energy and raw materials, new technologies and strategic foresight. The Russian invasion of Ukraine has clearly re-energized transatlantic ties and led to unprecedented Europe/US cooperation on coordinated sanctions on Russia and military support for Ukraine. It has also highlighted the importance of cooperation between Brussels and Washington on trade and technology.

However, beyond Ukraine, questions remain both on what the goals and the means of this rebooted relationship should be, in a world where the US will probably lose its position as sole superpower and Europe is still defining its role as a more unified actor in the global arena. How will (and should) the relation change given that not everything strategic can be done "at scale" by the US alone anymore? What would Europe's (new) role be? And for what purpose? Can NATO remain merely a defensive alliance in a world where non-NATO democracies are threatened, where preemptive action outside of NATO territory might be warranted, and where mutual defense promises can be construed as aggressive by adversaries? How will both sides of the Atlantic position themselves in the race towards new technologies, new standards, and new governance? How will they manage their relations with other major continents like Latin America, Africa, the Middle East, or the Asia-Pacific region?

This conference will attempt to shed some light on these questions and many others, one year after the Madrid NATO conference, coinciding with a critical moment for the (re)definition of world affairs and multilateralism in the years to come.
